

Copper Mountain Mine Field Trip

Dear Parent or Guardian,

MineralsEd in partnership with **Copper Mountain Mine** is organizing a one-day field trip on Friday October 25<sup>th</sup> for senior secondary students to travel to Copper Mountain Mine located ~20 km SW of Princeton BC.

The purpose of this field trip is **career exploration**. This modern mining operation employs some 430 people. The tour will provide students the opportunity to observe and learn about the mining process and the multifaceted nature of the operation which requires the skills of an array of personnel from equipment operators and environmental scientists, to HR administrators and engineers, to trades and technology specialists of many stripes, and payroll and accounting.

The students will be picked up at one of four pre-determined pick-up locations (Vancouver, Langley, Abbotsford, Princeton) and travel by charter, non-stop, to the mine. They will be met by and supervised on the bus and for the entire day by MineralsEd staff and volunteers throughout the day.

Mine staff will organize and supervise the tour when the students are on the mine site. Each student will be provided with appropriate safety gear, including reflective vest, steel toe boots, ear plugs and safety goggles for the tour. The tour will include: an introduction to the mining process and the Copper Mountain operation, a visit to the mine dispatch (control room), a tour one of the maintenance shops for mine equipment, a visit to the open pit to observe the mining process, and a walking tour the mill to observe how the copper is extracted from the ore. (Students will travel on a mine bus driven by mine personnel when moving around the mine site.) Mine staff will also share their training and career experiences, as well as present an overview of the operation's workforce.

The students will be accompanied, supervised and shepherded by mine staff and MineralsEd personnel throughout the day.

Lunch will be provided by Copper Mountain Mine. Please inform me if your child has specific food allergies.
